OVERVIEW

We're calling all artists young at heart to help us celebrate our first anniversary of a successful partnership with Pottery Barn Kids and PBteen! Last year's Minted art assortment was a big hit, and we're excited to announce that we are partnering again to source another unique collection of artwork. Pottery Barn Kids and PBteen are two of the biggest names in the teen and children's home decor market, and your winning pieces could be exposed to millions of potential customers in Pottery Barn Kids and PBteen stores, catalogs, social media, and websites.

In this challenge, Minted, Pottery Barn Kids, and PBteen will all select Editors' Picks. Pottery Barn Kids and PBteen will select at least 25 Editors' Picks each. At least 20 selections for each brand will either be featured in a Pottery Barn Kids or PBteen catalog or be sold in all of their retail stores for a period of time. See full details in the Editors' Picks section below.

Please note we are looking for art prints to span a wide age range covering babies, kids, and teens - anything from art for a upscale nursery to art for a chic college dorm room. Feel free to submit gender-neutral colors, and note that Pottery Barn Kids and PBteen strive to equally meet the needs of parents of boys and girls. We are not looking for customizable art in this challenge.

PRIZES, AS VOTED BY CONSUMERS AND ARTISTS

The top-rated designs will receive the following prizes:

- **FIRST PRIZE:** \$4,000 plus a trip to San Francisco to visit both Minted and Pottery Barn Kids & PBteen to tour offices and meet with the teams, or a personal video and photography package to enhance your brand.*
- **SECOND PRIZE:** \$2,000
- **THIRD PRIZE:** \$1,000
- **FOURTH - TWENTIETH:** \$300

EDITORS' PICKS AWARDS, AS CHOSEN BY MINTED'S EDITORIAL COUNCIL

Minted will select additional pieces for sale as Editors' Picks, with those artists receiving **\$200** prizes. All prints that are sold on Minted.com will also earn a **commission of 10% of net sales** of the products sold, per our Terms & Conditions. The ongoing commission is paid in addition to the upfront cash prizes.

An artist card including your name and short bio will be included in every order of your piece.

POTTERY BARN KIDS EDITORS' PICKS AWARDS

Pottery Barn Kids will select at least 25 art pieces as Editors' Picks, with those artists receiving **\$200** prizes (or instead a larger prize if the piece wins one of the larger prizes mentioned above in the community-voted section).

CREATIVE GUIDELINES

A. SUBMISSIONS

- ☐ You will be creating art prints. Your print will be available in a variety of sizes at Minted, ranging from 5x7" to 44x60".
- ☐ We are only accepting non-customizable art prints. Any type of art is accepted, from photography to illustrations and paintings.
- ☐ If submitting photography, please make sure your photograph is taken from a public location.
- ☐ You do not have to use templates provided in the submission kit, but using the templates may help to make your submissions look clearer.
- ☐ Foil-pressed submissions will be accepted for this challenge.

B. OTHER SUBMISSION NOTES

- ☐ **Repurposes:** As a reminder, please do not submit repurposes of your designs already for sale on Minted to this challenge. If you'd like to request that we repurpose your existing design into this category, please submit your request through our [form](#). Requests will be evaluated as a group while we're reviewing challenge submissions. More info in our FAQ [here](#).
- ☐ You may submit multiple designs; however please do not make multiple submissions of the same design with different colorways or minor tweaks. Need help deciding on which piece to submit? Try out a [poll](#)!
- ☐ Winners may be asked to submit 2 alternate colorways for their art print when applicable and a detailed description of the print. If you submit an art series, we may ask for additional pieces in the series.
- ☐ Submissions are limited to **30 per artist**. If one artist submits more than 30 pieces, we will only consider the first 30. This is a maximum limit (very few artists submit this much work) and we strongly encourage all artists to curate their submissions down to the strongest pieces.

C. TITLE

- ☐ Choose unique titles for your pieces. Be creative! Do not include the phrase 'Art Print' in your title, this will be added automatically.
- ☐ Please use only alpha-numeric characters in the design names (e.g., no commas, semi-colons, dollar signs, etc.). Be aware that adding spaces or other characters amidst the letters may, in the future, make searching for your design difficult.

D. FOIL-PRESSED DESIGNS

- ☐ Foil-pressed submissions will be accepted for this challenge.
- ☐ Foil-pressed elements must be non-customizable.

All pieces selected by Pottery Barn Kids will be sold online at www.potterybarnkids.com for at least 12 months. At least 20 of Pottery Barn Kids' pieces will either be displayed and sold in Pottery Barn Kids retail stores or featured in a Pottery Barn Kids catalog.

Pieces selected by Pottery Barn Kids will not be sold as limited edition. In addition to the upfront cash prize, artists will be paid by Minted a total of **10%** of the wholesale price that Pottery Barn Kids pays Minted (artists will be paid directly by Minted). For pieces that are shared with Minted, artists will earn the standard 10% of net sales generated on Minted.com.

Pottery Barn Kids will determine the size(s) and the default frame color in which each print will be sold on potterybarnkids.com. If your work is selected to be an exclusive work sold in a physical retail store, we may ask you for an alternate colorway that matches or coordinates with the retail stores' merchandise color palette.

An artist card including your name and short bio will be included in every order of your piece from Pottery Barn Kids (and Minted if it is a shared piece).

PBTEEN EDITORS' PICKS AWARDS

PBteen will select at least 25 art pieces as Editors' Picks, with those artists receiving **\$200** prizes (or instead a larger prize if the piece wins one of the larger prizes mentioned above in the community-voted section).

All pieces selected by PBteen will be sold online at www.pbteen.com for at least 12 months. At least 20 of PBteen's pieces will either be displayed and sold in PBteen retail stores or featured in a PBteen catalog.

Pieces selected by PBteen will not be sold as limited edition. In addition to the upfront cash prize, artists will be paid by Minted a total of **10%** of the wholesale price that PBteen pays Minted (artists will be paid directly by Minted). For pieces that are shared with Minted, artists will earn the standard 10% of net sales generated on Minted.com.

PBteen will determine the size(s) and the default frame color in which each print will be sold on pbteen.com. If your work is selected to be an exclusive work sold in a physical retail store, we may ask you for an alternate colorway that matches or coordinates with the retail stores' merchandise color palette.

An artist card including your name and short bio will be included in every order of your piece from PBteen (and Minted if it is a shared piece).

SPECIAL PRIZES, AS CHOSEN BY MINTED'S EDITORIAL COUNCIL

Among the top-rated pieces and Editors' Picks, Minted will award special prizes to these individual pieces. Special Prizes are decided by Minted's editorial council. All special prize winners will receive an 8x8 or 8x10 framed sample of their winning work.

- **Critique Award:** Nominate an artist who gave truly outstanding peer critique in this Challenge. Two winners will be randomly selected from the nominees: **\$50 Minted credit. Nominate [here](#).**

An important note about Special Prizes: As a reminder, Special Prizes are a form of Editors' Pick and are selected from previously announced Editors' Picks and top-rated selections. As such, Editors' Picks who are awarded Special Prizes will receive the applicable Special Prize amount in lieu of the Editors' Pick prize amount. Top-rated pieces who are awarded Special Prizes will receive the applicable Special Prize amount in addition to the applicable top-rated prize amount.

Special Prizes will be awarded at Minted's sole discretion. If for any reason, Minted cannot fulfill the described non-monetary Special Prize commitment, we will award you with a prize of equal or greater value.

EVERY MOTHER COUNTS CONTEST

Earlier this year we launched an exciting year-long contest involving our charitable partner, Every Mother Counts, a non-profit organization dedicated to making pregnancy and childbirth safe for every mother, everywhere. **The big news: later this year, two Minted artists will be selected to join Minted Founder Mariam Naficy**

On the trip, the winning artists will meet with one of Every Mother Counts' grantees and experience first-hand the work that they are doing to provide skilled and compassionate care to Haitian mothers throughout their pregnancies. To qualify for the trip, artists must submit two or more of our upcoming baby and kids' stationery or art challenges, plus submit a 250-word written or one-minute video statement later this year describing your interest in joining this trip and/or a personal experience or anecdote that conveys your connection to or passion for this issue. CMYK PROGRAM

As a reminder, Art is one of the main categories that can earn you a spot in our CMYK Program, Minted's top artists' program. CMYK membership is evaluated each year and awarded to top-selling artists. It is an excellent opportunity to qualify for brand-building benefits like marketing features, Julep posts, and one-on-ones with the Minted team. Our top CMYK artists receive a certain number of guaranteed Editors' Picks in the Art category, as well as quarterly commission bonuses.

Let's get started!

1 CREATE HIGH-RES ARTWORK

You will be creating art prints. Your print will be available in a variety of sizes at Minted, up to 44" x 60". Please note, we offer sizes ranging from 5x7" to 44x60" for art prints.

- For best results we recommend creating vector images. This will allow the artwork to scale up to any size without losing any of the image quality. If your final artwork will be non-vector based, please be sure to scan it in or create it at a high, for-print resolution. Your DPI should be set to 300. Make sure to set up your file for the largest print size as a full-bleed image that meets either the height or width requirements within the content area (38" x 54" or 38" x 38"). You are not required to use the templates provided in the submission kit.

2 CREATE LOW-RES SUBMISSION FILES

After you create your hi-res artwork, you will upload a low-res version for viewing in the challenge gallery. You will upload a low-res JPEG or GIF of your design. Your files must be 200kb, with the larger side at 550px. See the bar at right for instructions on how to save your work as a low-res file.

3 READ AND ACCEPT THE TERMS AND CONDITIONS

As part of the Entry Form, you will be asked to thoroughly read and agree to the Minted Terms and Conditions for Design Submissions. NOTE: Terms and Conditions are updated each challenge, and there is important information that you should know about. The Minted Terms and Conditions are included at the end of this document.

4 FILL OUT AN ONLINE ENTRY FORM AND SUBMIT

Submit your design at <https://www.minted.com/challenge/385>. You will be asked to log in or create an account. Please fill in the form and upload your submission. Please choose a unique title for your artwork, using only alpha-numeric characters.

5 WHAT HAPPENS NEXT?

After you submit, you can edit your design as many times as you want before the launch of voting. Login to your Design Studio, click on "Manage Your Collection" and click "edit" underneath the design you want to edit.

Who should I contact if I am having technical difficulties submitting?

Please read through the above FAQ first as your question may be answered there. If not, email us at artists@minted.com and someone will get back to you. We check this email regularly during business days.

How can I submit artwork created in a physical medium?

You will need to scan in your artwork and create it at a high, for-print resolution. For large-scale artwork, we suggest taking a high-quality photograph of the work or finding a local print shop or architectural firm that has the ability to scan larger items.

HOW TO PREPARE YOUR SUBMISSIONS FOR THE WEB

- Your submission must be in JPEG or GIF format. It must be under 200kb and the largest side must be 550 pixels max. Submission JPEGs must be saved in RGB color mode for online viewing on Minted.com.
- We recommend creating hi-res CMYK artwork, then saving it down a new, low-res RGB version when submitting to the challenge. Although only the low-res artwork is necessary for submission, if your piece wins, we will later ask for a high-res version.

ARTWORK CREATED IN ILLUSTRATOR

- From the File Menu, select 'Save for Web & Devices...'
- We recommend selecting the Preset 'JPEG High.' Quality 60 is usually fine, but it can be optimized as you see fit to get the best file size/quality ratio.
- Just below the presets menu, click on the 'Image Size' tab. Make sure the 'Constrain Proportions' box is checked.
- Set the largest side of your artwork to 550 pixels and click on the 'Apply' button, then save.

PLEASE NOTE

- If you win, final artwork created digitally will need to be in CMYK and bitmap elements at a minimum of 300dpi. Please no spot or RGB colors. You may use the Pantone Color Bridge CMYK/Uncoated guide, but be sure to always create your files using the CMYK build. You will need to include all linked files. Bitmap elements should be in TIFF format (not JPEG).

MINTED, LLC TERMS AND CONDITIONS FOR ARTWORK SUBMISSIONS

Minted, LLC (“Minted,” “we,” “our,” or “us”) appreciates your (“you,” “your,” or “Artist”) participation in the Minted contest set forth in the contest overview attached hereto (the “Contest Prize Overview”) (such contest, the “Contest”) via your submission of an artwork (hereinafter the “Artwork”). By submitting the Artwork to Minted, you agree to the following terms and conditions (“Terms and Conditions”):

You promise, represent and warrant that each and every Artwork you submit to Minted (a) is your own original work, (b) has not been previously published, distributed, sold or reproduced anywhere by any means in any physical medium (including in any books or magazines) other than (i) in a single original work if the Artwork was first produced in a tangible medium (e.g., watercolor or other painting or photographic negative) and/or (ii) no more than twenty five copies total of the Artwork sold by you prior to submission of your Artwork, (c) does not contain any trademarks, logos, or copyrighted material other than that which has been provided to you by Minted or that you solely own, and (d) does not contain any content subject to any right of publicity or privacy or any intellectual property belonging to any third party. You acknowledge that you will not use any content provided to you by Minted for any purpose other than to submit Artworks incorporating such content to Minted in connection with this Contest.

You acknowledge that Minted may decline to select an Artwork for voting on Minted.com (our “Site”) or as the winner of a cash award as part of the Contest (a “Prize”) for any reason in its sole discretion.

If the Artwork is selected to be displayed by Minted for voting on our Site, then you grant us the right to use, upload, modify, reproduce, create derivative works of, and display the Artwork for the purposes of promoting Minted and this Contest on our Site and otherwise throughout the world, in Minted’s sole discretion, both during the Contest and during the Trial Period (as defined below).

Whether or not we select the Artwork for a Prize, you may not offer for sale, sell, or submit the Artwork or Matching Items (as defined below) to others or otherwise publish, distribute, or reproduce the Work or allow others to do so for any purpose until the date that is 90 days after the Contest’s submission deadline (the “Trial Period”). After the expiration of the Trial Period, if Minted has not notified you that it has selected the Artwork for a Prize, then you will be free to use the Artwork for any purpose. Notwithstanding the foregoing, if you have been provided an Artist-specific, branded shopping area on a subdomain of the Site by Minted (a “Store”), to the extent you self-launched products incorporating the Artwork or Matching Items prior to submitting your Artwork to the Contest, subject to the terms and conditions governing your use of the Store, you may continue to sell such products via your Store during the Trial Period. If Minted selects your Artwork for a Prize, your Artwork will be subject to these Terms and Conditions, including the applicable Contest Prize Overview.

During the Trial Period, we may display the Artwork in connection with use on products offered for sale to assess consumer interest, even if we have not yet selected your Artwork for a Prize.

You hereby license us the use of your name and identifying information and image (“Artist Name”) for purposes of promoting the Artwork both during and after the Trial Period.

If your Artwork is selected for a Prize by Minted, effective upon such selection, you hereby immediately and irrevocably grant to Minted an exclusive (even as to you, subject to the License Conversion as defined below), sublicenseable (through multiple tiers), assignable, royalty-free, fully paid-up, irrevocable right to use, reproduce, distribute (through multiple tiers), create derivative works of, and publicly display and perform (publicly or otherwise) the copyright and all other intellectual property,

“moral,” and other rights in your Artwork and in any additional matching items set forth in the applicable Contest Prize Overview or otherwise requested by Minted or provided by you in connection with your Artwork (“Matching Items”) (the Artwork and Matching Items, collectively, the “Work”), including, without limitation, the right to copy, reproduce, make derivative works and sell or offer for sale the Work and products bearing the Artwork or derivative thereof or incorporating the Work or any derivative thereof, and to allow others to do the same. For clarity, the foregoing exclusive license of your right, title, and interest relating to the Work does not take effect until and unless the Artwork is selected for a Prize by Minted. Without limiting the foregoing, if the Artwork is selected for a Prize, Minted may, among other things, use the Work and your Artist Name in any manner, including but not limited to: (a) reproducing the Work, or portions thereof, and your Artist Name on products, (b) selling products (including but not limited to art prints, greeting cards, invitations, and stationery) bearing the Artwork or any derivative thereof or incorporating any aspect of the Work or any derivative thereof and which may include or be associated with your Artist Name (subject to Minted’s obligation to pay you the Sales Commission as defined and described below) and which may be, in Minted’s sole discretion, sold via the Site and/or your Minted Store, if applicable, (c) changing or reworking the Work by making color or size changes, (d) making derivative works of the Work and (e) using the Work and your Artist Name on our Site and otherwise to promote Minted.

In the event that Minted elects to no longer offer the Artwork for sale as a Limited Edition Artwork or Minted has sold all available editions (in all sizes and colorways you provided) of the Limited Edition Artwork, the foregoing exclusive license granted to Minted shall convert to a perpetual non-exclusive license, without limiting any of the other licensed rights set forth above (such conversion to a non-exclusive license, the “License Conversion”). For the avoidance of doubt, (i) Minted shall retain the sublicenseable (through multiple tiers), perpetual, assignable, royalty-free, fully paid-up right to use, reproduce, distribute (through multiple tiers), create derivative works of, and publicly display and perform (publicly or otherwise) the copyright and all other intellectual property, “moral,” and other rights in the Work on a non-exclusive basis, including, without limitation, the right to copy, reproduce, make derivative works and sell or offer for sale the Work and products bearing the Artwork or derivatives thereof or incorporating the work or any derivative thereof, and to allow others to do the same and (ii) License Conversion shall not terminate or otherwise impact, limit or restrict Minted’s ownership of any Minted Stationery Product (as defined below) or the license granted by you in connection with any such Minted Stationery Product as set forth below.

Notwithstanding anything to the contrary in these Terms and Conditions, to the extent Minted elects to launch (rather than your self-launch of) a stationery product incorporating or constituting a derivative work of your winning Artwork or Matching Items as permitted herein (a “Minted Stationery Product”), you (a) acknowledge and agree that Minted shall be the sole and exclusive owner of all right, title and interest in and to the Minted Stationery Product, including all the copyright and all other intellectual property, “moral,” and other rights in the Minted Stationery Product, excluding the rights that you maintain in the Artwork and/or Matching Items and (b) effective upon such launch by Minted, grant Minted the perpetual, sublicenseable (through multiple tiers), assignable, royalty-free, fully paid-up, irrevocable right to use, reproduce, distribute (through multiple tiers), and publicly display and perform (publicly or otherwise) such applicable Artwork and/or Matching Items and all in intellectual property rights therein

connection with the Minted Stationery Product, including, without limitation, the right to copy, reproduce, and sell or offer for sale the Minted Stationery Product, and to allow others to do the same. Without limiting the foregoing, even in the event of a License Conversion, Minted may, among other things, (a) sell the Minted Stationery Product without restriction, which may include or be associated with your Artist Name (subject to Minted's obligation to pay you the Sales Commissions as defined and described below), (b) change or rework the Minted Stationery Product by making color or size changes, (c) use the Minted Stationery Product on our Site and otherwise to promote Minted, and (d) register the Minted Stationery Product with the U.S. Copyright Office or any other copyright office in Minted's or Minted's designee's name. You agree to provide Minted with any information as may be required in order to register the copyright in the Minted Stationery Product if Minted so requests, at no additional cost to Minted. You agree and acknowledge that you will not obtain any rights in or to any Minted Stationery Product, other than the rights you maintain in the Artwork and/or Matching Items, and that nothing herein constitutes a license, or other permission, allowing you to copy, reproduce or sell or offer for sale any Minted Stationery Product, even in the event of License Conversion.

All Artworks selected for a Prize by Minted may be sold by Minted as limited edition Artworks ("Limited Edition Artworks"). You acknowledge that certain laws may require Minted to track and disclose the number of copies of the Artwork that exist in any form and otherwise govern the sale of Limited Edition Artworks. In addition to any other rights granted to Minted or anything to the contrary contained herein with respect to your Artwork, for each Limited Edition Artwork: (a) you grant Minted the right to sell the Artwork as a Limited Edition Artwork, including via the Site and your Store and (b) you grant Minted the right to set the maximum quantity available of the Limited Edition Artwork in each size and colorway for the purposes of offering the Limited Edition Artwork as a limited edition product and to make all decisions regarding the availability of Limited Edition Artworks for each edition. In addition to the foregoing, Minted may require you to enter into an additional agreements governing Limited Edition Artworks and you agree to execute such additional agreements upon request from Minted and to otherwise comply with all requirements related to Limited Edition Artworks that Minted may make available to you from time to time (including, without limitation, requirements related to providing Minted with information necessary to comply with laws governing the sale of Limited Edition Artworks). For each Limited Edition Artwork, the foregoing paragraph and any other terms and conditions related to Limited Edition Artworks shall survive any termination of any agreement between you and Minted, including, without limitation, the termination of these Terms and Conditions.

If the Artwork is selected for a Prize, for so long as the Artwork is sold as a Limited Edition Artwork by Minted, you may not reproduce, sell, or otherwise use or distribute the Work or derivatives thereof, in any manner whatsoever or allow others to do so, including making products bearing the Artwork or derivatives thereof or incorporating the Work or any derivatives thereof in any form, including for your personal use or as gifts to friends or other third parties, provided, however, if the Artwork was created from a tangible single original work (e.g., a painting), Minted grants you the right to display the original work and transfer it to someone else, but you, and anyone who obtains the original work from you, cannot reproduce or authorize others to reproduce the original in any medium or create derivative works of the original work. In the event of License Conversion, you agree that you will not or allow any other person to reproduce, sell, or otherwise use or distribute the Work in the size and colorways in which Minted sold the work as a Limited Edition Artwork prior to the License Conversion.

To the extent that you submit an Artwork to the Contest that was previously self-launched via your Store and Minted selects such Artwork for a Prize, in Minted's sole discretion, Minted may, upon selecting the Artwork for a Prize, transfer or convert any products bearing the Artwork or any derivatives thereof, or incorporating the Work or any derivatives thereof, that you previously self-launched in your Store as necessary, including converting any such art prints into a Limited Edition designation on your Store and deducting the number of such products you sold via your Store prior to the date of such transfer from the available number of Limited Editions of such products.

Nothing in these Terms and Conditions obligates Minted to promote or sell the Artwork or the Matching Items, even if the Artwork is selected for a Prize.

If the Artwork is selected for a Prize, then we shall pay you a lump sum cash Prize amount and a Sales Commission, as set forth below and in the applicable Contest Prize Overview. All Prize amounts are in U.S. dollars. Minted may, in its sole discretion, also select Editor's Picks and/or recognize other categories of top Artworks (including as voted by the community) as Prize winners, as specified in the applicable Contest Prize Overview, each of which will be deemed selected for a Prize.

If the Artwork is selected for a Prize by Minted at any time after the Trial Period, Minted may notify you of its selection and you may accept or reject the Prize.
